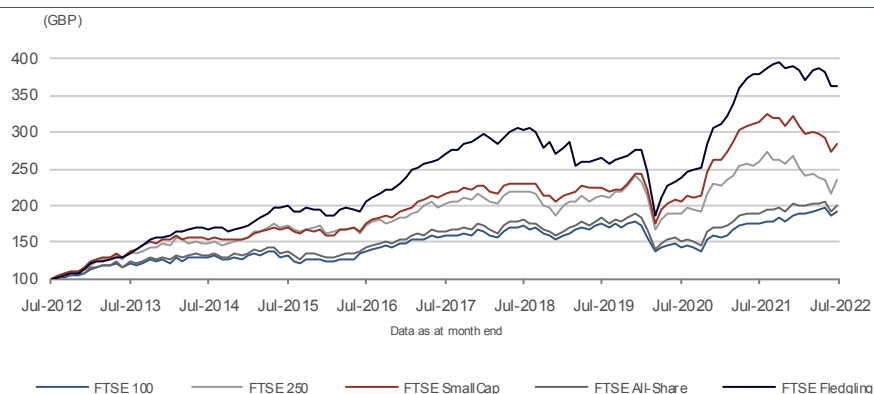


# FTSE 100 Index (Chinese)
